NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely:-

- 1. Short title and commencement.-** (1) These rules may be called the Rajasthan Civil Services (Pension) (Amendment) Rules, 2026.
(2) They shall come into force with immediate effect.

2. Amendment of rule 67.- The existing condition (ii) and (iii) of proviso to rule 67 of the Rajasthan Civil Services (Pension) Rules, 1996, hereinafter referred to as the said rules, shall be substituted by the following, namely:-

- "(ii) before allowing the family pension for life to any such son or daughter, the appointing authority shall satisfy that the disability is of such a nature so as to prevent him or her from earning his or her livelihood and the same shall be evidenced by a certificate obtained from,-
- (A) an authority competent to issue disability certificate in accordance with the Rights of Persons with Disabilities Act, 2016 (Central Act No. 49 of 2016), the Rights of Persons with Disabilities Rules, 2017 and the guidelines and notifications issued by the Central Government or State Government or Union Territory administration; or
- (B) a Medical Board comprising of a Medical Superintendent or a Principal or a Director or Head of the Institution or his nominee as Chairman and two other members, out of which at least one shall be a Specialist in the particular area of disability, setting out, as far as possible, the exact mental or physical condition of the child,
- (iii) the person receiving the family pension as guardian of such son or daughter or such son or daughter not receiving the family pension through a guardian shall produce a certificate from,-
- (A) an authority competent to issue disability certificate in accordance with the Rights of Persons with Disabilities Act, 2016 (Central Act No. 49 of 2016), the Rights of Persons with Disabilities Rules, 2017 and the guidelines and notifications issued by the Central Government or State Government or Union Territory administration; or
- (B) a Medical Board comprising of a Medical Superintendent or a Principal or a Director or Head of the Institution or his nominee as Chairman and two other members, out of which at least one shall be a Specialist in the particular area of disability including mental retardation,

once, if the disability is permanent and if the disability is temporary, once in every three years, to the effect that he or she continues to suffer from a disability."

3. Amendment of rule 134.- In sub-rule (1) of rule 134 of the said rules,-

- (i) in clause (ix), for the existing expression “; or”, appearing at the end, the punctuation mark “;” shall be substituted;
- (ii) in clause (x), for the existing punctuation mark “.”, appearing at the end, the expression “;” shall be substituted; and
- (iii) after the existing clause (x), so amended, the following new clause (xi) and (xii) shall be added, namely:-

"(xi) all serving government servants except class IVth employees of State Government may issue life certificate to the pensioner/family pensioner by e-signing / authenticating through their SSO ID ; or
(xii) pensioner may submit life certificate using the face authentication technology system based on UIDAI Aadhar software."

4. Amendment of Form 14.- In Form 14 appended to the said rules,-

- (i) the existing clause 12 and entries thereto shall be substituted by the following, namely:-

"12. Attested by:

Name	Full address	Signature
....."; and

- (ii) the existing Note shall be substituted by the following, namely:-

"**Note:** Attestation should be done by only one Gazetted Officer or one person of respectability in the town or village in which the applicant resides."
